How to apply :

Interested candidates will have to submit their application online in PRESCRIBED format provided in the website www.wbprd.gov.in. Candidates are advised to read the instructions carefully before submitting online application. Application can be submitted online with effect from 11 am of 15th November, 2014. The last date for submission of completed application is 28th November, 2014 upto 5.30 PM.

Important Notes:

- 1. The selection will be based on performance in written test and personal interview. A presentation is to be made before the Selection Committee by the candidates during interview process.*
- 2. Candidates are requested to clearly fill in the application form and ensure that personal E-mail id and contact telephone details have been given therein. This is required for quick and timely communication.*
- 3. The filled in application must be submitted ONLINE only. Incomplete applications will be rejected. No application will be entertained after last date and time as mentioned or if sent through any others system.*
